

GREYHOUND WELFARE & INTEGRITY COMMISSION DISCIPLINARY ACTION DECISION

Charge(s):	Charge 1 - LR166A
	That on twenty-five occasions Mr. Stone, as a registered Public Trainer, engaged in conduct of lay betting against greyhounds that he trained.
Plea:	Guilty
Disciplinary action taken:	To issue an eight-week suspension, wholly and conditionally suspended for twelve months subject to Mr. Stone not breaching this or any like rule in this period.

DECISION:

- 1. Mr. Stone was, at all relevant times, a registered Public Trainer with the Greyhound Welfare and Integrity Commission.
- 2. On twenty-five separate occasions, between 3 August 2022 and 27 September 2023, Mr. Stone engaged in lay betting against greyhounds that he trained.
- 3. On 10 November 2023 Mr Stone was issued a Notification of Stewards Inquiry, inviting Mr. Stone to a hearing to be held on Wednesday 15 November, in which the circumstances of the above-mentioned bets would be ascertained.
- 4. On 4 December 2023 Mr. Stone was issued with a notice of charge and proposed disciplinary action ("**Notice**"). The Notice issued a charge against him for breach of the following Greyhound Racing Rule:

Charge 1– Local Rule 166A Rules

(1) A person, being a trainer, will be guilty of an offence if the person:

(a) places a bet on a greyhound, other than a greyhound trained by that person, in a race in which they have a starter;

(b) places any type of bet on a greyhound, other than a greyhound trained by that person, in a race to finish ahead of a greyhound they train in the race.

- 5. The Notice invited Mr. Stone to attend a hearing on 8 December 2023 and to enter a plea and make submissions in relation to the charge.
- 6. Mr Stone contacted the decision makers on 8 December 2023 and;
 - Entered a plea of guilty; and
 - Made written submissions.
- 7. After considering Mr. Stone's plea and written submissions, the decision makers found the charge proven and took the following disciplinary action against him:
- Charge 1 To issue an eight week suspension, wholly and conditionally suspended for twelve months subject to Mr. Stone not breaching this or any like rule in this period.
- 8. In taking this disciplinary action, the decision makers considered all evidence, including:
 - Mr. Stone's Guilty plea
 - Mr. Stone's short registration history, with no prior offences for a similar matter
 - Personal and professional circumstances
 - In assessing penalty, the decision makers considered the overall performance of Mr. Stone's greyhounds in relation to the above bets, which did not identify any integrity concerns.
