- Business plan detailing your:**
  - Business structure**
  - How you will communicate with syndicate members and/or prospective members**
  - How you will manage the accounts of a syndicate and settle payments to members**
- Statement of assets and liabilities**
- Two written references attesting to your conduct of business**
- A copy of the Offer Document that you propose to use**
- A certified copy of your business or Company certificate of registration**

- c) If the Commission later determines that information I have provided in this form is incomplete, incorrect or deliberately false, disciplinary action may be taken against me, which could include suspension or disqualification of my registration or a warning off;
- d) I will immediately advise the Commission if there is any change to the particulars or information I have provided in this form;
- e) While I am a greyhound racing industry participant, I will comply at all times with the provisions of the Greyhound Racing Act 2017, Greyhound Racing Regulation 2019, Greyhound Racing Rules, Code of Practice and the Commission's policies, as may be in place from time-to-time.
