4. Prerequisites for Breeder Registration

- Tracy noted Breeding is complex and it is not something that can just be done without experience and training there is a lot of factors to it. Considers the need to have more than just a Handlers or Attendants licence prior to getting a Breeders licence
- Jenny noted the difference between an owner breeder and a commercial breeder (whelper)
- Barry concurred on the comments made from Tracy and Jenny particularly on the segregation between a "breeder' and a 'whelper'. A greater onus in terms of compliance and training on those who can whelp pups
- Suggest a 2-tier set up; a breeder and a breeder/whelper
- Juliet noted GWIC do assess the compliance of physical areas as a part of the application process, but does not look at the other side of whelping / care of greyhounds
- Barry noted the high cost of whelping litters, that if we allowed everyone to breed straight away then there would be a reluctance for people to pay experienced whelpers, which could lead to negative welfare matters
- Tracy noted the need for an owner breeder category say on the form could be broken into three are you the owner Yes, are you the breeder Yes, are you the whelper, No, then the details of the whelper has to be completed so that owner breeders don't have to transfer ownership of their bitches to a breeder for the whole process
- Juliet noted the need for those to get a Breeder/Whelper licence there is a need for both training courses and evidence of practical experience

5. Earbranding / Microchipping ages



- Tracy noted she recently had a litter earbranded at the 15 weeks but considers they should be done between the 10-12 week mark, not only for a commercial matters in terms of the pups going out to their new owners along with the growing sensitivity of the pups ears
- Matt noted with the two dedicated officers and the developing of a schedule should see this even out to the more ideal timeframe
- Jenny noted that 12 weeks should be the threshold
- Matt noted that there is a push from GA to move away from the earbranding
- A look to phase out earbranding
