- b) If the Commission later determines that information I have provided in this form is incomplete, incorrect or deliberately false, disciplinary action may be taken against me, which could include suspension or disqualification of my registration;
- c) The Commission may check any details of the information I have supplied in this form and I consent to the Commission collecting, using and disclosing my personal information, and any other information contained within this form, including to any third party, where such disclosure is necessary to process this form;
- d) I will immediately advise the Commission if there is any change to the particulars or information I have provided in this form;
- e) While I am a greyhound racing industry participant, I will comply at all times with the provisions of the Greyhound Racing Act 2017, Greyhound Racing Regulation 2019, Greyhound Racing Rules, Code of Practice and the Commission's policies, as may be in place from time-to-time.
- f) To be an eligible company means a proprietary company that is registered under the Corporations Act 2011 of the Commonwealth and in which
 - i. each director, shareholder and person concerned in the management of the company is of or over the age of 18 years, and
 - ii. each director is registered as a bookmaker under the Greyhound Racing Act 2017, and
 - iii. each director is a shareholder and person concerned in the management of the company, and
 - iv. each shareholder who is not a director is a close family member of a director, and
 - v. each shareholder or person concerned in the management of the company who is not a director is, in the opinion of the Commission, a fit and proper person to be registered as an individual as a bookmaker under the Greyhound Racing Act 2017, and
 - vi. no shareholder or person concerned in the management of the company, other than a director, is registered as an individual as a bookmaker, and
 - vii. subject to the regulations, no person (other than a shareholder) has any interest in the shares or assets of the company.
- g) It is a condition of a company's registration as a bookmaker that the company continues to be an eligible company
 - i. is a director, shareholder or person concerned in the management of, or is an employee or agent of, any other company that is registered as a bookmaker, or
 - ii. has a financial interest in any business of a bookmaker that is carried on by any such other company under the authority of its registration, or
 - iii. is registered or otherwise authorised as an individual to carry on, or carries on, the business of a bookmaker, bookmaker's clerk or turf commission agent, or a totalizator business, or any other kind of betting, wagering, gambling or gaming business, in another country, or
 - iv. is a director, shareholder or person concerned in the management of a corporation, or is a member of a partnership, that is registered or otherwise authorised to carry on, or that carries on, any such business in another country, or
 - v. is an employee or agent of any individual, partnership or corporation, referred to in subparagraph (iii) or (iv), or
 - vi. has a financial interest in the business of a bookmaker or turf commission agent, or a totalizator business, or any other kind of betting, wagering, gambling or gaming business, that is authorised to be carried on or is carried on in another country.
