5. Group Ownership Policy consultation - Group Policy Internal Link

- Matthew Tutt presented the draft Group Ownership Policy and asked GIPAC for any feedback
- Jason Lyne noted the private syndicate system would be a positive change
- A Query as to whether to register a syndicate "name" or the names of the lead owner, setting a limit to how many names could form the syndicate name
- There is no maximum amount of people in the private syndicate
- At a minimum the Manager of the syndicate would need to be a registered participant
- ASIC is involved in any public syndicates which is highly regulated by the federal government
- A need to look at the back end arrangements for ensuring private syndicate manager would need to be trustworthy
