Charge(s): (1) Mrs. Braddon presented the greyhound 'Zeb's Magic'

("Greyhound") for the purposes of competing in race 5 at the Cowra meeting on 5 October 2018 in circumstances where the

Greyhound was not free of any prohibited substance.

Prohibited substance(s): Tolfenamic acid

Disciplinary action taken: Fine: \$560.00

REPORT:

Following receipt of a certificate of analysis from the Racing Analytical Services Laboratory, the Commission conducted an investigation into the results of a post-race urine sample taken from the greyhound, 'Zeb's Magic' ("**Greyhound**") at the Cowra meeting on 5 October 2018.

Further analysis of the sample was conducted by the Australian Racing Forensic Laboratory, confirming the presence of tolfenamic acid.

After considering the evidence, the Commission charged Mrs. Braddon with a breach of Greyhounds Australasia Rule ("GAR") 83(2)(a) given that the post-race urine same taken from the Greyhound confirmed the presence of prohibited substance tolfenamic acid.

Mrs. Braddon admitted the charge at the earliest opportunity.

The disciplinary action was conducted in writing in accordance with the participant's election.

DECISION:

- Mrs. Braddon is a registered greyhound trainer and the trainer of the Greyhound. The Greyhound competed in race 5 at the Cowra meeting on 5 October 2018 ("Event"). Following the Event, as the Greyhound placed first, a urine sample was taken from the Greyhound.
- 2. The post-Event swab revealed the presence of tolfenamic acid. Tolfenamic acid is a prohibited substance under GAR 1 of the GWIC Greyhound Racing Rules. Tolfenamic acid is a category 5 prohibited substance under the NSW greyhound racing penalty guidelines. Category 5 is the lowest category of prohibited substance.
- 3. The Commission charged Mrs. Braddon under GAR 83(2)(a), which reads:
 - (2) The owner, trainer or person in charge of a greyhound-
 - (a) nominated to compete in an Event;
 - (b) presented for a satisfactory, weight or whelping trial or such other trial as provided for pursuant to these Rules; or
 - (c) presented for any test or examination for the purpose of a period of incapacitation or prohibition being varied or revoked

shall present the greyhound free of any prohibited substance.

- 4. Mrs. Braddon admitted the charge at the earliest opportunity and elected to have the disciplinary proceeding conducted in writing.
- 5. The Commission found the charge proven and took the following disciplinary action against Mrs. Braddon:

To impose a fine in the sum of \$560.00.

- 6. In taking this disciplinary action, the Commission considered all evidence, including:
 - Mrs. Braddon has been a registered trainer for 24 years;
 - Mrs. Braddon has no history of any prohibited substance matters;
 - NSW greyhound racing penalty guidelines and precedents;
 - Mrs. Braddon's admission at the earliest opportunity.
- 7. In addition, the Greyhound was disqualified from race 5 at the Cowra meeting on 5 October 2018 pursuant to GAR 83(4), which reads:

(4) A greyhound presented for an Event pursuant to sub-rules (1) or (2) shall be

d	isqualified from the Event or any benefit derived from a trial or test.
