

## GREYHOUND WELFARE & INTEGRITY COMMISSION DISCIPLINARY ACTION DECISION

Charge(s):	Mr Mark Farrugia presented the greyhound 'My Three Boys' for the purpose of competing in race 8 at the Richmond meeting on 6 December 2024 in circumstances where the Greyhound was not free of any prohibited substance
Prohibited Substance(s):	Meloxicam
Plea:	Not Guilty
Disciplinary action taken:	To issue a fine of \$1,000 as well as impose a 4 week suspension, which will be wholly and conditionally suspended for 12 months subject to Mr. Farrugia not reoffending under the same or similar rules in this period.

## INVESTIGATION

Following receipt of a certificate of analysis from Racing Analytical Services Limited, dated 13 January 2025, the Commission conducted an investigation into the results of a pre-event urine sample taken from the greyhound, "My Three Boys" at the Richmond meeting on 6 December 2024.

Further analysis of the sample was conducted by the Racing Chemistry Laboratory confirming the presence of Meloxicam.

## **DECISION:**

- 1. Mr Farrugia is a registered Public Trainer and Breeder and the trainer of "My Three Boys" ("**the Greyhound**"). The Greyhound competed in race 8 of the Richmond meeting on 6 December 2024. Prior to the Event, a urine sample was taken from the Greyhound.
- 2. The pre-event swab revealed the presence of Meloxicam.

- 3. Meloxicam, in excess of the screening limit of a mass concentration of 5 nanograms per millilitre in a sample of plasma or 2 nanograms per millilitre in a sample of urine, is a prohibited substances under Rule 146 of the Rules.
- 4. On 10 March 2025 Mr Farrugia was issued with a notice of charge and proposed disciplinary action ("Notice"). In the Notice, the decision makers charged Mr Farrugia with an offence under Rule 141(1)(a) of the Greyhound Racing Rules, which reads: Rule 141(1), Rules
  - (1) The owner, trainer or other person in charge of a greyhound:

(a) nominated to compete in an Event;

must present the greyhound free of any prohibited substance.

(3) The owner, trainer or person in charge of a greyhound presented contrary to subrule (1) of this rule shall be guilty of an offence.

- 5. The Notice invited Mr Farrugia to attend a hearing on Wednesday 26 March 2025 at which time he would have the opportunity to enter a plea and make submissions in relation to the Charge and proposed penalty. The penalty proposed in the notice was a 2-month suspension.
- 6. On Monday 17 March 2025 Decision Makers requested the hearing date be moved to Monday 24 March 2025, to which Mr. Farrugia consented.
- 7. On Monday 24 March 2025 decision makers heard the matter via Microsoft Teams. Mr Farrugia attended the hearing and;
  - Entered a plea of not guilty; and
  - Made verbal submissions in respect of the proposed disciplinary action.
- 8. Following consideration of Mr Farrugia's plea and submissions, the decision makers found the charge proven and determined to take the following disciplinary action against Mr Farrugia:

**Charge 141(1)(a):** To issue a fine of \$1000 as well as impose a 4 week suspension, which will be wholly and conditionally suspended for 12 months subject to Mr. Farrugia not reoffending under the same or similar rules in this period.

- 9. In taking this disciplinary action, the decision makers considered all the material and evidence before them, including:
  - Mr Farrugia's plea of not guilty
  - Mr Farrugia's disciplinary history over a registration period of 30 years, with no prior prohibited substance offences.

- Mr Farrugia's forthright evidence and commitment to reviewing and improving husbandry practices.
- GWIC penalty guidelines.
- 10. In addition, the Greyhound was disqualified from race 8 at the Richmond meeting on 6 December 2024 pursuant to Rule 141(4) of the Rules.
