Miss Smith has acted improperly, by failing to check-in or

provide end of life or retirement notifications for her

greyhounds.

Charge 2 – 156(h)

Miss Smith, when directed to complete overdue eTrac Check-

ins for greyhounds in her care failed to comply with this

direction.

Plea: Charge 1 – No plea entered.

Charge 2 – No plea entered.

**Disciplinary action taken:** Charge 1 – To issue a suspension until such time her

greyhounds are checked-in or the relevant end of life or retirement notifications are completed and submitted.

**Charge 2** – To issue a suspension until such time as her greyhounds are checked-in or the relevant end of life or retirement notifications are completed and submitted.

## **DECISION**

- 1. Miss Smith was at all relevant times, a registered Owner with the Greyhound Welfare and Integrity Commission.
- 2. At all material times the greyhound, the subject of the charges was registered in Miss Smith's ownership.
- 3. On Thursday, 2 October 2025, following an investigation by the Commission, a Notice of Charge and Proposed Disciplinary Action ("Notice") was issued to Miss Smith. The Notice issued two charges under the Greyhound Racing Rules alleging a breach of the following:

## Charge 1: Rule 156(f)(ii)

#### 156 General offences

An offence is committed if a person (including an official):

. . .

- (f) has, in relation to a greyhound or greyhound racing, done something, or omitted to do something, which, in the opinion of a Controlling Body or the Stewards:
  - (i) is corrupt, fraudulent, or dishonest;
  - (ii) constitutes misconduct or is negligent or improper;

### Charge 2: Rule 156(h)

#### 156 General offences

An offence is committed if a person (including an official):

. . .

- (h) disobeys or fails to comply with a lawful order of a Controlling Body, the Stewards, or another person authorised by a Controlling Body with official duties in relation to greyhound racing;
- 4. The Notice invited Miss Smith to make submissions in relation to the charges and penalty. The penalties proposed in the notice were:
  - **Charge 1 -** To suspend Miss Smith until such time her greyhounds are checked-in or the relevant end of life or retirement notifications are completed and submitted.
  - **Charge 2 -** To suspend Miss Smith until such time her greyhounds are checked-in or the relevant end of life or retirement notifications are completed and submitted.
- 5. On 9 October 2025, Miss Smith contacted the Commission regarding the check-in requirements for her retired greyhound and was provided with information about the available options to complete the check-in process.
- 6. As at the date of this decision, the greyhound in question has not been checked-in.
- 7. The decision makers imposed the following penalties:
  - **Charge 1 -** To suspend Miss Smith until such time her greyhounds are checked-in or the relevant end of life or retirement notifications are completed and submitted.
  - **Charge 2 -** To suspend Miss Smith until such time her greyhounds are checked-in or the relevant end of life or retirement notifications are completed and submitted.

8.	The Commission's inquiries into the whereabouts of the greyhounds remain ongoing.
