**Charge 1 – R156(f)(ii)** 

Ms Francis has acted improperly, by failing to check-in or provide end of life or retirement notifications for her

greyhounds.

Charge 2 - 156(h)

Ms Francis, when directed to complete overdue eTrac Check-

ins for greyhounds in her care failed to comply with this

direction.

Plea: Charge 1 – No plea entered.

Charge 2 – No plea entered.

**Disciplinary action taken:** Charge 1 – To warn Ms Francis off until such time her

greyhounds are checked-in or the relevant end of life or retirement notifications are completed and submitted.

**Charge 2** – To warn Ms Francis off until such time as her greyhounds are checked-in or the relevant end of life or retirement notifications are completed and submitted.

#### **DECISION**

- 1. Ms Francis was at all relevant times, a greyhound racing industry participant.
- 2. At all material times the greyhound, the subject of the charges was registered in Ms Francis's ownership.
- 3. On Wednesday, 12 November 2025, following an investigation by the Commission, a Notice of Charge and Proposed Disciplinary Action ("Notice") was issued to Ms Francis. The Notice issued two charges under the Greyhound Racing Rules alleging a breach of the following:

## **Charge 1: Rule 156(f)(ii)**

## 156 General offences

An offence is committed if a person (including an official):

. . .

- (f) has, in relation to a greyhound or greyhound racing, done something, or omitted to do something, which, in the opinion of a Controlling Body or the Stewards:
  - (i) is corrupt, fraudulent, or dishonest;
  - (ii) constitutes misconduct or is negligent or improper;

## **Charge 2: Rule 156(h)**

#### 156 General offences

An offence is committed if a person (including an official):

. . .

- (h) disobeys or fails to comply with a lawful order of a Controlling Body, the Stewards, or another person authorised by a Controlling Body with official duties in relation to greyhound racing;
- 4. The Notice invited Ms Francis to make submissions in relation to the charges and penalty. The penalties proposed in the notice were:
  - **Charge 1 -** To warn Ms Francis off until such time her greyhounds are checked-in or the relevant end of life or retirement notifications are completed and submitted.
  - **Charge 2 -** To warn Ms Francis off until such time her greyhounds are checked-in or the relevant end of life or retirement notifications are completed and submitted.
- 5. Ms Francis failed to respond and make submissions in relation to the charges or penalties by Wednesday, 19 November 2025.
- 6. The decision makers imposed the following penalties:
  - **Charge 1 -** To warn Ms Francis off until such time her greyhounds are checked-in or the relevant end of life or retirement notifications are completed and submitted.
  - **Charge 2 -** To warn Ms Francis off until such time her greyhounds are checked-in or the relevant end of life or retirement notifications are completed and submitted.
