A greyhound owner or custodian who retires a greyhound must provide this form to GWIC within 14 days from the date of retirement.

Clause 10(1)(f) of the Greyhound Racing Regulation 2019 provides authority for the Commission to ask you for information in relation to your greyhound.

Your application must include a certificate of desexing when retired outside of greyhound industry
